Contributors to *Translation Times. Texts, Contexts and Environments* should observe the specific instructions below.

### CRITERIA FOR PUBLICATION

The primary criteria for judging the acceptability of a manuscript are: its originality, scientific importance, and interest to a general linguistic audience.

Articles should be submitted to [titela.vilceanu@edu.ucv.ro](mailto:titela.vilceanu@edu.ucv.ro). We recommend you submit the entire manuscript, including tables and figures, as a single word (standard DOCUMENT (.DOC)) and PDF file.

**Length of article:** 5,000 -10,000 words

**Title** : up to 75 characters; bold, centered. Titles should not be capitalised. Font: Times New Roman, 14 pt

**Affiliation**: Department, University/organization, institutional e-mail address, ORCID number. If the article is co-authored, one of the authors should be designated as the corresponding author to whom inquiries regarding the paper should be directed.

**Abstract**: 100-200 words, TNR 10 pt, single

**Keywords**: 5-10 key words, TNR 10 pt, single, italics

## IMPORTANT!

### Citations and quotations

In the text, citations should be indicated by the name of author/editor and the date in parentheses:

- One author: (Desjardins 2017).
- Two or three authors: (Hatim and Munday 2005).
- Four and more authors: (Large et al. 2019).
- Several works by one author/editor: (Baker 1992, Baker 2006).
- Page number: (Desjardins 2017, 28) or number range: (Desjardins 2017, 28-32).

Quotations:

- Short quotations (less than 100 words) should appear in the running text and be enclosed in double quotation marks.
- Longer quotations should appear in a separate block without quotation marks. The reference with page number(s) should be placed at the end of the quote after punctuation.
- Quotations in languages other than English should be followed by translations (in square brackets).
- The citation to the source should be placed at the end of quotation (see the examples above).

**Examples** should be indented left 1 tab (1 cm) and written in font Times New Roman, 10 pt. They should be separated from the text (one space above and one space below) and numbered within brackets. Inverted commas should not be used.

**Footnotes** and **endnotes** should be avoided.

**Tables and charts** should be inserted **AS OBJECTS** which can be moved with the text. They should be numbered consecutively, with Arabic numbers. They should be referred to by their numbers within the text.
