### Reality and fictional gap-filling in Colum McCann's TransAtlantic

Colum McCann's novel *TransAtlantic*, published in 2013, brought its contribution to the author's already established fame. Born in Dublin, Column McCann has travelled to the United States, Japan and eventually settled in New York where he taught creative writing in Hunter College. *TransAtlantic* is a proof of his art craft while also being firmly tight to substantially documented real events that intertwine with fictional narratives having women as protagonists and covering a two-century span. The novel catches in its fictional web historical events such as the first transatlantic flight (1919), the visit of the American social reformer and abolitionist Frederick Douglass to Ireland (1845-1846) and the peace process in Ireland at the end of the twentieth century (1998). A letter that crosses the ocean links the events like a gossamer detail charging the characters with emotion and empathy. The paper aims at identifying and presenting the way in which reality is mirrored and interrelates with fictional characters and events in Colum McCann's *TransAtlantic*.

A Pocket-Mirror for the Fancies: Shaftesbury on Self-Division, Self-Reflection, and the Freedom of Thought

The main illustration that accompanies *Soliloquy*, or *Advice to an Author* in the second edition of Lord Shaftesbury's famous *Characteristics* depicts two allegorical versions of the self, each equipped with a pocket-mirror that is being handled in two very different ways. In short, the first allegorical figure is shown looking straight into his mirror and closely inspecting the clear and distinct impressions that surround his head, while the second averts his anguished gaze and is violently overtaken by a vicious group of harpies. This key illustration deliberately acquaints the reader with the main lineaments of Shaftesbury's self-disciplining method of soliloquy, which is compounded of Socratic and Stoic elements and requires self-division and self-dialogue. The chief question that I'd like to answer in my paper has to do with the specific role that this mirror for the mind performs in the self-regulating process that Shaftesbury

envisages. How exactly does self-reflection work in such a way as to rectify and reorder one's thoughts and imaginations? To what extent does this process presuppose self-censure and self-denial - and what does this tell us about Shaftesbury's specific conception of 'discipline'? What can be said of the tension between imaginative freedom and imaginative discipline that this technique presupposes? Such questions are apt to provide new insights into the specifics of Shaftesbury's poetics and aesthetics at the heart of which lies this self-discursive and self-reflective approach to the self.

# Der "Spiegel" im Spiegel der Zeit. Metaphern im Text als Indiz für Sprachwandel

Seit seiner Gründung 1947 ist das wöchentlich erscheinende deutsche Nachrichtenmagazin ..Der Spiegel" ein kritischer Beobachter bundesdeutschen Politik, Wirtschaft und Gesellschaft und wird zu den einflussreichsten Medien Deutschlands gezählt. Seine sprachlich-stilistischen Eigenheiten veranlassten bereits 1957 Hans Magnus Enzensberger zu einer kritischen Betrachtung der "Sprache des 'Spiegel". Wenn die Sprache der Presse aus linguistischer Perspektive als "Indiz für die Tendenzen der Gegenwartssprache" verstanden werden kann (Lüger 1995: 21), gilt dies auch für ein einzelnes Publikationsorgan. Der Beitrag setzt sich zum Ziel, am Beispiel des "Spiegel" Indizien für Sprach- und Stilwandel der deutschen Pressesprache in diachronischer Perspektive aufzuzeigen. Im Fokus stehen sprachliche Strategien, die bei der Behandlung brisanter Themen zum Einsatz kommen, wobei der Metapher als Ausdruck von Konzeptualiserungsprozessen (Lakoff/Johnson 2003/1980) besondere Aufmerksamkeit gewidmet wird, da sie nicht nur im Dienste der Informationsvermittlung steht, sondern auch bei der Meinungsbeeinflussung eine bedeutende Rolle spielt. Untersuchungsgegenstand des Beitrags ist ein Korpus von Titelgeschichten des "Spiegel", die in wichtigen Zeitabschnitten der bundesdeutschen Geschichte erschienen sind: die junge Demokratie der 50er Jahre, die 68-er Bewegung und die Wiedervereinigung, die erste Bundeskanzlerin, die RAF. rechtspopulistische AfD.

Media discourse – between an objective reflection of reality and emotionalism

Media coverage of dramatic events aims to produce emotional responses in readers (ranging from compassion to concern), responses that are guided by means of linguistic devices and discursive strategies aiming to enhance the impact of the news. This presentation makes an analysis of the ways in which English language newspapers (the online editions of *The Sydney Morning Herald* and *The Guardian*, the international edition) elicit emotion while reporting on the bushfires that ravaged Australia in 2019. Quotes from experts (local authorities, politicians, police and firefighters' representatives, weather reporters) and local residents are used to create a complex (objective and subjective) image of the situation, and numerous figures of speech give a poetic account of the fires. The analysis will show that, while generally structured so as to create dramatic tension and elicit negative emotions, at times reports on natural disasters aim to arouse the readers' positive responses and reconsideration of their social role and cultural identity.

# The Enlightenment as Wunderkammer: Mirabilia, Knowledge and the Paradigm of *Homo Narrans*

The paradox of the Enlightenment as both rational and gullible never ceases to amaze contemporary scholars who highlight the division between the classical world of reason and the rhetoric of modernity. The metaphorical intertwined with the rational and mirabilia (a collection of the wonders of the East) intertwined with John Locke's empirical knowledge in an attempt to mirror 'the crisis of the European mind' reflected the controversial attitudes toward such concepts as 'Truth' and 'Nature.' The crisis of authority mirrored both a crisis in authenticity and one of representation, which affected the European literary stage of that period and resulted in the publication of fraudulent books. Newtonian physics and Psalmanazar's fictitious Formosan language were both part of the Enlightenment. This paper aims to reflect on the Enlightenment as Wunderkammer, a cabinet of curiosities that mapped out a territory of reverberating stories told by homo narrans about the mirabilia of the East: looking in the geographical mirror, the European storyteller marvels and wonders at the paradigmatic ambivalence of knowledge which reasonably served to decode the metaphorical meanings of existence.

### The Posthuman Self in Octavia Butler's Kindred

This study interprets Octavia Butler's novel *Kindred* as a Middle Passage narrative through the lens of posthumanist theory. The focus is on the transformations of the black body and psyche while being constantly transported in the past, present, and future. Even though the intricacies of unmaking of Dana Franklin remain mostly invisible, the effects of the multiple temporalities leave scars on the main character's already multiple consciousness. The novel renders a historical awareness of trauma through its protagonist's experiences and behaviours, but it also epitomizes the fragmented essence of her conditioning.

### The Representation of Mental Clauses from a Functional Perspective

The paper looks at a text by Seamus Heaney – From the Frontier of Writing – through linguistic lenses, analysing the way in which complex blends and novel cognitive models are created in the mind of the reader. Meaning construal in the arborescent mirrors of poetic discourse is thus discussed from the cognitivist perspective of reader experience and the interplay of multidimensional frames, schemas, and mental spaces. Far from being mere esthetic entertainment, poetry is shown to offer the reader/writer a privileged space for practicing and learning

essential mental skills such as empathy and creativity in the same way in which children practice and learn basic life and language skills and ways of interaction when enacting frames and schemas in the games they play.

## Nach Lust und Laune, die Art und Weise, rank und schlank: Lexikalisierte Zwillingsformeln im heutigen Deutsch

Der Wortschatz des Gegenwartsdeutschen kennt eine ganze Reihe festgeprägter koordinativer Verknüpfungen vom Typ A und B, in denen Erst- und Zweitausdruck derselben Wortart angehören. Vorliegender Beitrag macht sich zur Aufgabe, solche formelhafte Wortpaare sprachwissenschaftlich zu beleuchten. Dabei werden die genannten Konstruktionstypen zunächst auf ihre Binnenstruktur, auf ihre Semantik sowie auf ihre Produktivität und ihre typischen Gebrauchskontexten hin untersucht. Das Herzstück der Analyse soll jedoch ihrer stilistischen und pragmatischen Funktionen gewidmet werden. Zwillingsformeln stellen teil- oder vollidiomatisierte Phraseme dar, die eindeutig emphatisch und stilistisch markiert sind. Solchen Wortpaaren liegt eine allgemeine sprachliche Strategie der Intensivierung Expressivitätssteigerung zugrunde. Die Hinzufügung eines weiteren mehr oder weniger sinnverwandten Lexems ist zwar nicht sprachökonomisch, dient aber der emotional gefärbten Verstärkung. Die wesentlichen Quellen der Expressivität solcher Wendungen wie Alliteration (Haus und Hof) bzw. Endreim (Lug und Trug) und semantischer Doppelungseffekt (blind und taub durchs Leben gehen) werden ebenfalls unter die Lupe genommen.

# Reflecting on the supervisory relationship: Students' perceptions on bachelor thesis writing

The bachelor thesis is a high stakes writing genre which poses difficulties for many students, particularly in contexts where students have little experience with academic writing during their undergraduate programs. In such situations, supervisors have an important role in helping students navigate the challenges of thesis writing. However, while doctoral supervision has been researched extensively, there is comparatively much less research on master and bachelor thesis supervision (Scholefield and Cox, 2016).

This paper presents two case studies of Romanian students who reflect on the process of writing their bachelor theses and on the relationship with their supervisors. Data collection was undertaken during the COST Action IS1401 Strengthening Europeans' capabilities by establishing the European literacy network (ELN) via semi-structured interviews, and students were also asked to reflect on their experience by using a visualization instrument (journey plots; see Miller & Brimicombe, 2003; Sala-Bubaré & Castelló, 2017). While there were significant differences between the way in which the two participants interacted with their supervisors, both cases show the importance of the supervisors' role, but at the same time suggest that students are empowered when they can develop a sense of ownership of their thesis and of the writing process.

### Cognitive Strategies in Teaching English *Neck* and *Throat* Idioms

According to Cognitive Linguistics, in the case of most idioms, there are three cognitive mechanisms (conventional knowledge, metaphor and metonymy) thatcan act like mirrors,reflecting figurative meaningsthroughliteral ones. In the light of the above, our paper attempts to stress the important role that the aforementioned cognitive strategies play in the process of *neck* and *throat* idiom acquisition. We thus carried out an experimental study which involved the use of two different teaching approaches (traditional and cognitive). By comparing our students' responsiveness to each method and by assessing their results in the final test paper, we managed to point out the advantages of activating cognitive strategies while teaching English *neck* and *throat* idioms.

### Some Current Reflections on Multimodal Translation

Engaged in the constant upgrading of the communication framework, which tends to be relocated within virtual environments via digitized modes, crowdsourcing and cloud-based platforms, translators need to keep up with both challenges and opportunities. Under the circumstances, the translation of multimodal texts does not only complement the service provision agenda of the translation market, but multimodality itself becomes a resource for translation. In this respect, López Rodríguez et al. (2013) highlight the crucial role played by images in the development of current thematic maps and word banks. Aiming to develop trainees' technological and encyclopedic competence, we design and implement a translation-oriented virtual project to reflect some contemporary views on the input of multimodal corpora in translation training. In line with current trends regarding virtual environments applied to enhance trainees' self-reliance and resourcefulness to meet current demand-driven market requirements, we aim to mirror the contribution of the multimodal approach to translation training.

# Students' Perceptions on the Benefits of English as a Medium of Instruction in Higher Education

In recent years, English as a Medium of Instruction (EMI) is seen as a way to develop internationalization at the institutional level, to promote staff and student mobilities and to improve university ranking, so all important Romanian universities have included these goals in their strategic plans for 2016-2020 and 2020-2024. However, the actions taken in this direction are less visible, and only a small number of EMI-based study programmes have been included in the study offer in the last years. In this context, our paper examines aspects related to EMI in the context of higher education at the University of Craiova (UCV), with a focus on the students' perceptions on EMI's institutional and personal benefits. The aim is two fold. On the one hand, we analyse the

policies and strategies developed and implemented at institutional level with regard to BA and MA English-taught programmes put in place to address the above-mentioned goals. On the other hand, we present the results of a questionnaire-based research carried out at the Faculty of Automation, Computers and Electronics, Department of Computer Science (English-taught programme), aimed at analysing the benefits of EMI according to the students' perceptions. The preliminary results indicate thateven the more 'experienced' English-taught programmes of UCV have faced new challenges and limitations, and despite the clear-cut benefits rated by the students, there are still many obstacles to overcome so as to achieve the objectives stipulated in the institutional strategies and policies.
