FIRST CALL FOR PAPERS

"Deface the currency." (Pythian proverb)

What are rules after all if not common opinions, established conventions, the truth and the moral coin of the masses over generations? And what is the value of rules? Can they be bent or broken? Have bending and breaking them become a common trend in our times?

By scorning the common opinion and making no allowance for traditional social conventions, the Cynic philosophers, through their most notable representative, Diogenes, suggest that any norm or rule, just like a coin or banknote, can be defaced, mutilated or altered to empty it of any value. Thus, by reducing or inverting the value of rules, the cynics promoted a new type of individual freedom, encouraged free thinking, outside the inherited limitations and constraints of rules. However, their boldly challenging of customs and received ideas might not only empower the "know thyself" principle, but also lead to a state of libertarian anarchy.

Nietzsche, a great admirer of the principles of the cynic philosophers, takes the task of breaking rules a step further by describing them as a parasitical, stifling form of moral control, a tool in the hands of the Church. Can rules thus be regarded as a form of moral manipulation? Do they obliviate the individual? Do they depersonalize?

Together we will embark on a mission to try and find answers to these questions and many more by analysing how cultural policies relate to rules as a form of control, and also how social (including moral) rules have found their reflection (and deflection) in literature. Education equally benefits from challenging limitative rules, with teaching methodology becoming fundamentally student-centered, and aiming at an ever more effective learning.

The very concepts designated by the terms *rule*, *principle* and *norm* are fundamental in communication and commonly encountered in linguistics. Despite being sometimes used interchangeably, do these terms refer to the same thing? In *A Dictionary of Linguistics and Phonetics* (2008), David Crystal explains that, while rules are formal statements of

correspondence between linguistic elements or structures, principles are broader in their scope, currently essential in both grammar and pragmatics; for example, in GB theory, we can find only principles that take a fairly different form in various languages. As to norms, the linguist points out that they refer to "a standard practice in speech or writing", being proper to normative grammar. That leads us to the two opposite approaches, linguistic prescriptivism and linguistic descriptivism. The former seeks to lay down rules (prescriptions) in terms of how language should be used in a correct way, and thus establish a standard language. If with prescriptivism rules do not only command, but also forbid, the descriptive approach goes beyond (standard) rules, focusing more on acceptability than on correctness and being thus non-judgmental and evidence-based, in an attempt to show the way in which language is or was actually used by the members of a speech community.

Last but not least, translation studies also benefit from the approaches related to norms and rules applied to translation as a process and a product, including the establishment of quality standards.

To conclude, this year's conference welcomes contributions from fields as varied as literature, discourse studies, art, philosophy, cultural and gender studies, theoretical and applied linguistics, translation and comparative studies, history and the humanities in general. The conference strives at achieving a multidisciplinary and interdisciplinary quality and we therefore extend a warm invitation to scholars and postgraduate students doing research in a range of disciplines.
